4. First aid measures

7. Handling and storage

- Handling** : Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Avoid exposure - obtain special instructions before use. Do not get in eyes or on skin or clothing. Do not ingest. 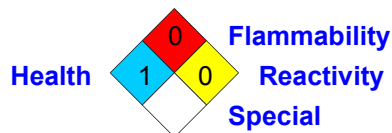
